Part 2. Share Options

Basic Veggie Package: May 31, 2017 through October 11, 2017

Total for CSA: \$500.00

*20 weeks at \$25.00 per week

Part 3. Payment Plan

We have 2 payment options for the CSA....

[] You can make one payment for the total amount of the CSA, \$500.00 OR,

[] You can make monthly payments for your CSA. Payments will be the total minus the deposit fee split evenly into 4 monthly payments. Total after deposit will be \$450. The payment schedule will be as follows.... May 31 (first CSA pickup)- \$125, June 28- \$125, August 2- \$100, September 6- \$100

There will be a \$50 dollar deposit fee to hold your CSA spot due at the time you submit your application. This is taken out of the total of the CSA amount so it is not an additional fee. If you are paying the full season amount then there is no deposit because your full payment is the deposit! The deposit is non-refundable once the CSA has started on May 31, 2017.

Part 4: Optional Bonus Add on: 4 weeks of value added products, 1 quart per week. These jars will be a \$1 less than you can buy them at market. I plan to put a pasta sauce, dill pickles and salsa. The 4th jar will be determined during harvest season. These jars will be delivered the last 4 weeks of the season. The total will be 4 weeks x \$11 a jar so \$44 total. If you choose this option we will just split the amount over your 4 payments.

Part 4. Terms of Agreement

I, _____, commit to membership in the Gratefull Gardens CSA for the 2017 harvest season (May 31—October,11). I understand that if I fail to pick up my share, it cannot be made up another week. I understand that the practice of farming is inherently unpredictable, and though the farmers of Gratefull Gardens will do everything in their power to ensure fresh high quality produce, there is no guarantee of the quantity or contents of weekly shares.

The Shares

As a member of the CSA, I will receive a weekly share of produce for the growing season. These shares will vary by size and weight depending on the time of season. By joining a CSA, members agree to support local farmers through the sharing of the risks and rewards inherent in growing food. CSA farmers plan for problems such as poor weather, drought, disease, and crop failure that could jeopardize the shares. By growing a wide variety of crops that thrive in different conditions, cover cropping, rotating crops and irrigating, CSA farmers minimize risks to the CSA share holders, and optimize rewards. In the extremely unlikely event, however, that a natural disaster does result in preventing Gratefull Gardens CSA from continuing a weekly distribution, I will be notified immediately via the email that I have provided.

Member Responsibilities

As a CSA member, I agree to pick up my share during the pickup window. If I will be away or otherwise unable to pick up my share, I will make arrangements for someone else to pick it up for me. Any shares not claimed within 3 days of pickup will be donated. Member shares that are not picked up will not be made up or refunded.
